

Competition Rules

- 1. The "Grenadier livery competition" competition (the "Competition") is open to everyone aged 18 or over on 15 December 2020 who has:
 - a. informed us of their preference to receive English language communications from us: and
 - b. received an invitation email which contains a link to these "Competition Rules".
- 2. There is no prize or gift associated with the Competition, which is conducted subject to these Competition Rules.
- 3. It is the responsibility of each entrant to ensure that they have read and abided by the Competition Rules. INEOS' decision is final as to whether an entry is eligible to participate in the Competition.

HOW TO ENTER

- 4. Entries for the Competition must:
 - a. create their own design; and
 - b. email their design to info@INEOSGrenadier.com.
- 5. No entries will be accepted by mail or other media.
- 6. The Competition opens on 15 December 2020 and closes at **MIDNIGHT** (Greenwich Mean Time) on 4 January 2021. **No entries can be accepted after this time.** Please make sure that you allow enough time to complete your entry.
- 7. Only one (1) entry may be submitted per person.
- 8. A maximum of two (2) winners will be drawn from those entries which (a) meet the qualifying criteria and (b) submit a design for the Competition entry. The designs will be judged by INEOS, the decision criteria will involve the design being practical to make (50%) and visually appealing (50%). The decisions of INEOS (acting reasonably) will take place within fourteen (14) days following the closing date of the Competition and will be final. The winner will be notified by email within thirty (30) days of the close of the Competition.
